KNOW ALL MEN BY THESE PRESENTS:

That the undersigned incorporators have this day associated themselves for the purpose of forming a non-profit corporation under the laws of the State of Arizona and do hereby adopt the following Articles of Incorporation.

- 1. NAME. The name of the corporation shall be BLACKHAWK PROPERTY OWNERS ASSOCIATION, a non-profit corporation.
- 2 PURPOSE. The corporation is organized to maintain and improve the common readways, along with gates, fences, cattle guards and culverts involving such readways, and any common areas, facilities and water wells so designated by the Board of Directors, to collect assessments for the cost of such maintenance, and to enforce the Declaration of Covenants. Conditions, and Restrictions for the property known and to be known as the Ruger Ranch, Phase 3. Further, the corporation is organized to provide an entity for the furtherance of the best interests of the property owners in the development.
- CHARACTER OF AFFAIRS. The character of affairs of the corporation will be as a Property Owners Association.
- A No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 2. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or

distribution of statements), any political campaign on behalf of any candidate for public office

The corporation may be dissolved with the assent given in writing and signed by not less than seventy-five percent (75%) of the members. Upon the dissolution of the corporation, other than incident to a merger or consolidation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all its assets exclusively for the purposes of the corporation in such a manner, or to such non-profit corporations or, associations, trusts or other such organizations devoted to such similar purposes, as determined by the Board of Directors and approved by a majority vote of the members entitled to vote, present at a duly held meeting called for that purpose. Any such assets not disposed of shall be disposed of by the Superior Court of the county in which the principle office of the corporation is then located, exclusively for such purpose or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purpose.

6. INDEMNIFICATION OF OFFICERS, DIRECTORS, EMPLOYEES,

AND AGENTS. The corporation shall indemnify any person who incurs expenses by reason of the fact he or she is or was an officer, director, employee, or agent of the Association. This indemnification shall be mandatory in all circumstances in which indemnification is permitted by law and shall be made by the corporation whether the legal action brought or threatened is by or in the right of the corporation or by any other person.

7 BOARD OF DIRECTORS. The initial Board of Directors shall consist of three (3) Directors. The number of persons to serve on the Board of Directors thereafter shall be fixed by the Bylaws and shall not be fewer than three (3). The Directors shall be elected at the times and in the manner designated in the Bylaws.
